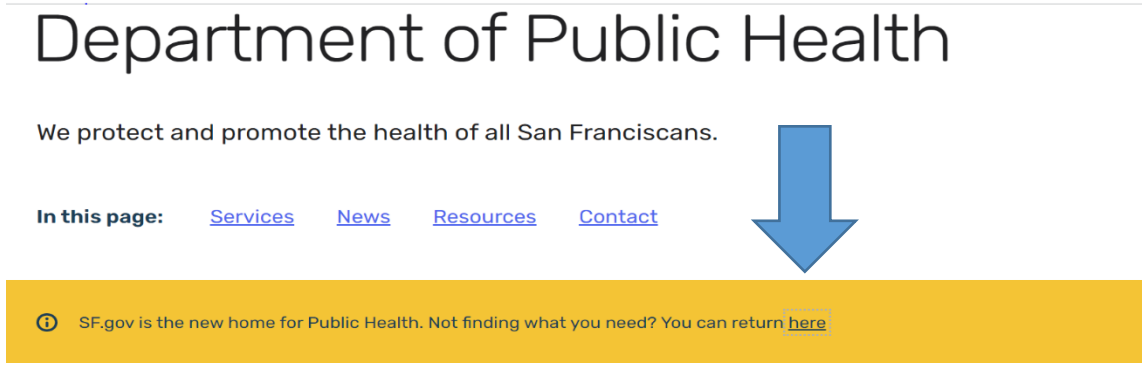

Below are the instructions for the Annual Compliance and Privacy Training.

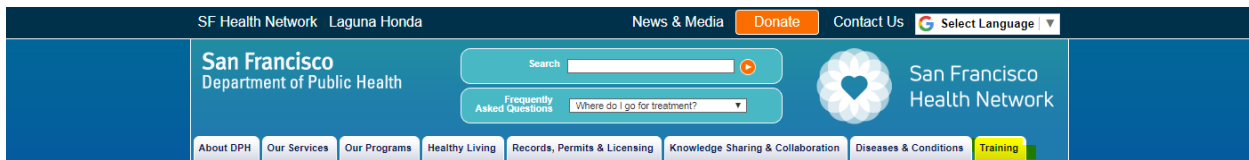
There are two modules to complete, one quiz to take, and two documents to electronically sign.

Steps:

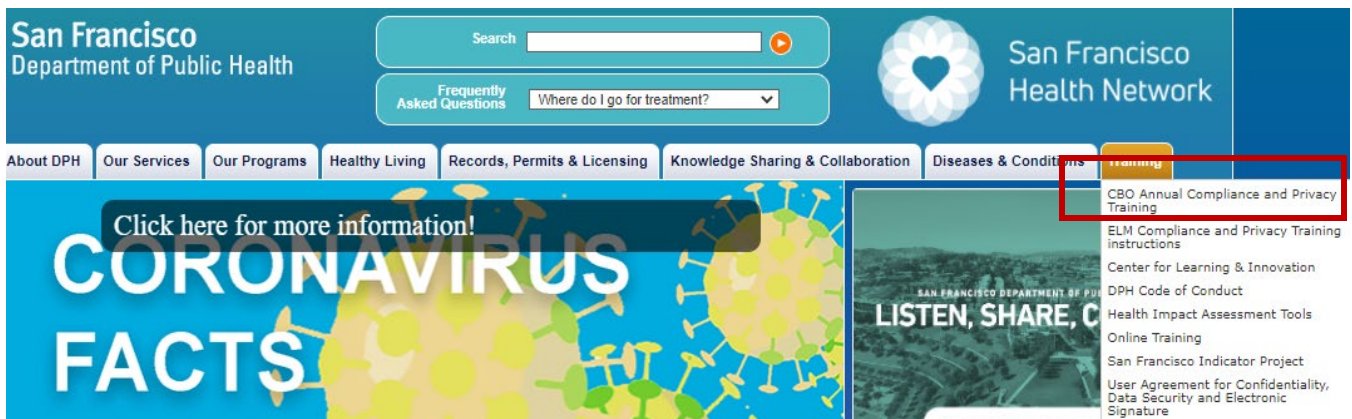
1. Go to www.sfdph.org. You will see this page, click the link in the yellow bar to access the training link.
